Dear Customer,

We've sold over 200 sheitels and are delighted to do the same for you!

Please read the consignment agreement carefully, accurately fill it out, and put your signature on the end of page two. You can bring the form to us when you drop off your sheitel or mail it with your sheitel.

To ensure that we are providing our clients with the highest quality of previously owned sheitels, we only consign European and human hair pieces that have been *gently* worn. We cannot accept sheitels with bald spots, tangling problems, shedding, botched dye jobs, low-quality hair, or synthetics.

We love to hear from you, so please feel free to contact us with any questions or comments.

Sheitel Consignment Agreement

- A. The listing price for the sheitel will be agreed upon by Classic Sheitels (CS) and the sheitel's owner and noted on the agreement by CS. If your sheitel sells, or an offer has been made that needs to be discussed with you, we will notify you through call or email. You will receive 50% of the sheitel's final sale price when the sheitel is sold. Checks will be mailed to you within 30 days of the sale.
- B. For beauty and cleanliness, sheitels must be freshly washed and styled. Your sheitel will sell more quickly when it looks and smells terrific. We provide this service for \$30 if you choose to have us wash and set your sheitel for you.
- C. If you are sending your sheitel by mail, please send a check for \$30 (**MADE OUT TO LENA FLEMINGER**) so it can be washed and styled in Baltimore. We find that sheitels do not look their best after a ride in the mail. Our address is **3930 Fallstaff Rd., Baltimore, MD, 21215.**
- D. In the event that the original owner knowingly misrepresents something about the sheitel to CS, and the sheitel is sold, owner agrees to return the money she has received, and must also cover any expenses that the buyer has incurred, with receipt.
- E. Initial consignment period is three months. During this time, CS takes possession of the sheitel and the original owner agrees not to sell it through any other venue and authorizes CS to sell the sheitel in our store and on the web. At the end of three months, the owner can continue to try selling the sheitel through CS, or may come and pick it up. The original owner is responsible for keeping track of when the three months are up.
